Dear Parish Councillor/resident

You are invited to attend a virtual consultation on Wednesday 12<sup>th</sup> January 2022 commencing at 7pm. This will be held using Zoom and the access details for the meeting are at the end of this notice.

The only way that the Parish Council can legally meet to make decisions is in person and face coverings must legally be worn inside community venues. This is not appropriate or practical and so a scheme of delegation has been put in place to allow the Clerk to act on behalf of the Parish Council. This will ensure that business can continue until such time as either legislation allows for a virtual/hybrid meeting, or a physical meeting is more appropriate. This is a temporary measure, and the intention is to return to holding Council meetings as soon as reasonable.

In order to maintain as much of the democratic process as possible, the Clerk will consult at a virtual meeting with members of the public and Councillors. Anyone not able to take part, may contact the Clerk in advance by email with written representations which will be taken into consideration.

Members of the Council will then have an opportunity to discuss any matters arising from previous meetings and be updated on any ongoing business.

Following the meeting, the Clerk will officially make decisions, taking into account all feedback received, in consultation with the Chairman and Vice Chairman.
