## Decisions to be made under the Scheme of Delegation January 2022

### 1. Planning, tree works and other applications (decision to support, object, and/or comment): -

#### 1.1. [P/FUL/2021/05005](#) (Full Planning Application)

Proposal: Erection of Agricultural Building

Location: Throop Hollow Farm, Throop Hollow, Throop, DT2 7JD

**DECISION:** To OBJECT The full submission of the Parish Council can be viewed on Dorset Council's Planning Portal.

**REASON:** The building is not essential for the purpose of agriculture associated with the farm holding or the expansion detailed in the Application.

#### 1.2. [P/FUL/2021/05230](#) (Full Planning Application)

Proposal: Erect 5 loosebox stables, feed and implement shed and tractor shed (Retrospective)

Location: Land to the East of Bladen Valley, Briantspuddle

**NOTE:** An extension has been granted to the Consultation period. This was requested by the Parish Council as there had been a delay to erection of planning site notices. This Application (Retrospective) will be considered at the February Parish Council meeting.

#### 1.3. [P/PAEW/2021/05433](#) (Prior Approval Application)

Proposal: Excavation of site for the construction of a silage clamp for the storage of winter forage for the dairy herd.

Location: Newburgh Dairy, Road to Newburgh Farm, Winfrith Newburgh, DT2 8DE

**NOTE:** The Parish Council is not a Consultee to this application. The matter was considered as information only and in the context of how it might link to the Slurry Lagoon in Affpuddle as the sites are run by the same enterprise.

#### 1.4. [6/2021/0072](#) (Planning Appeal)

Proposal: Ground floor rear extension to form sunroom

Location: Okerswood Cottage, Oakerswood, Affpuddle, Dorchester, DT2 8QZ
