You are invited to attend a virtual consultation on Wednesday 9<sup>th</sup> February 2022 commencing at 7pm. This will be held using Zoom and the access details for the meeting are at the end of this notice.

A scheme of delegation has been put in place to allow the Clerk to act on behalf of the Parish Council. This will ensure that business can continue at times when the Parish Council is not able to meet face to face. This is a temporary measure, and the intention is to return to holding Council meetings as soon as reasonable.

In order to maintain as much of the democratic process as possible, the Clerk will consult at a virtual meeting with members of the public and Councillors. Anyone not able to take part, may contact the Clerk in advance by email with written representations which will be taken into consideration.
